

Ashland Inc. Board Declares Regular Quarterly Dividend

COVINGTON, Ky., Nov 4, 2004 /PRNewswire-FirstCall via COMTEX/ -- The board of directors of Ashland Inc. (NYSE: ASH) today declared the regular quarterly dividend of 27.5 cents per common share on the company's stock, equivalent to an annual dividend of \$1.10 per share.
